## Project consists of:

Construction of new retrofit metal roof system over existing low slope roof structure. The building or building elements to receive the new retrofit roof is comprised of six (6) building areas with at total building area of approximately 11,200 square feet. Work shall include continuous gutter and downspouts and related trim/ break metal for a completed project.
